

The T2202 is your official tax receipt used to claim the eligible educational expenses for the tax year on your income Tax return. The form includes the amount of tuition that can

be claimed as well as the number of months eligible for the education deduction.

The 2020 T2202 is now available through online services for students on Concordia's web site.

If you received bursary or scholarship money in 2020 from Concordia, you will receive a T4A. Your T4A tax slip is issued for amounts received over \$500.00. If you have given consent, you are able to access your T4A through Online services for students under *Requests*.

Controlling COVID-19 in China: Crisis management one year "in"

The COVID-19 pandemic has started new conversations about the future role of surveillance technologies in health crisis management. Situations of crisis are critical for organizations (in this case, a country). They either break down or reinvent themselves. In this talk, Ausma Bernot and Dr. Marcella Siqueira Cassiano will present their analysis of China's response to Covid-19 from three perspectives: social-political, technological, and psychological, based on the State Council policies, including guidelines from the National Health Commission.

Ausma Bernot is a PhD Candidate at Griffith University, the School of Criminology and Criminal Justice (Australia). She has seven years of work experience with forensic science and research organisations across the globe, in particular China. Her current research interests focus on the effects that the merging of infotech and biotech triggers in the fields of governance, surveillance, policing, and public safety.

Dr. Marcella Siqueira Cassiano holds a PhD in Sociology from the University of Alberta. She is a Lecturer in Sociology and Criminology at Concordia University of Edmonton, and a Postdoctoral Research Fellow at the Department of Sociology of the Memorial University of Newfoundland. She researches population governance issues in China and Canada.

It's Tax Season!

While you are a student, you will receive special tax forms that reflect your income and expenses.

Not sure how to do your taxes? <u>Click here</u> to learn.

Create your Canada Revenue Agency (CRA) account here.

T4A

If you received grant or scholarship money in 2020, you will receive a T4A. A T4A is a statement of income for grants, scholarships and awards related to your education and is applicable if you received \$500 or more from a combination of those sources over the previous tax year. Student loans are not considered income and so T4As are not issued for student loan funding.

Most T4A's are electronic documents which you will need to retrieve.

Where to get your T4As:

Scholarships & Bursaries processed through CUE: Online Services for Students

Alberta Grants or Awards/Scholarships: your AB Student Aid online account

Canada Student Grant for Full-time students: NSLSC Online Services

Tax Receipts:

Tax receipts are issued to students who paid interest on a student loan. A 17% tax credit is available on the interest portion of Alberta Student Loan and Canada Student Loan payments!

Tax receipts for interest paid on your Alberta student loan: <u>MyLoan</u> Tax receipts for interest paid on your Canada student loan: <u>NSLSC Online Services</u>

T2202

A T2202 is an income tax receipt issued if you paid tuition fees that are eligible to claim on your income taxes. Log into <u>Online</u> <u>Services for Students</u> to retrieve your T2202.

T2202 & T4A will be available through Online Services for Students by end of day February 28, 2021.

If you need help with your taxes, contact the Canada Revenue Agency.
