

# **Violation Statistics for March 2022**



The restricted time zones surrounding Concordia had the following results:

- March 1-18, 2022 17 patrols, 19 tickets issued, 84 vehicles chalked
- + March 21-Apr 1, 2022 14 patrols, 42 tickets issued, 142 vehicles chalked

As a result of the notable increase in violations, parking Enforcement have set up additional patrols for this area.

## TIPS TO IDENTIFY AN EMPLOYMENT SCAMS IN CANADA:

#### 1. The employer is offering you money for nothing

- Employers will not give you money before you start working. Be wary if they offer you money before you meet them, especially if they are asking for the money back in gift cards, cryptocurrency, etc.
- Often the money that they send you (through a cheque etc.) will not be accepted by the bank, so the money you send them will be your own.

## 2. The employer is asking you for money

• Employment scams may say that the money is for the uniform, needed equipment, or other reasons. In Canada, you do not need to pay money to be hired for a job. As soon as an 'employer' asks you for money, be wary.

### 3. The employer is using pressure tactics

• The 'employer' may try to discourage you from contacting your bank or the authorities through time limits and other means. They may also threaten to retract the job offer in order to pressure you to send them the money.

## 4. The employer is not being professional

- If the employer is texting you, responding to emails all day (even past 5 pm and on weekends), and/or being too friendly be wary. Employers will use email or phone calls (not texting) to communicate and are very busy. They will not have the time to keep in contact with every applicant all day!
- Legitimate employers will not ask you for your personal information (address, SIN number, banking information, Alberta Student Number, relationship status, etc.) in your job application or before you sign a contract. When you receive a legitimate job, you may need to provide personal information in order to be paid, but you will typically fill out those Government of Canada forms on your first day of work.
- If you are unsure, contact Career Services.

### What can I do to minimize the chance of being targeted for an employment scam?

- If you have a 'gut' feeling that something isn't right trust it! It is better to be safe than sorry.
- Do not include your address on your resume and cover letter (eg. "Edmonton, Alberta" instead), nor other sensitive information such as your SIN, Alberta Student ID, Passport Number, etc.
- If you have been targeted by a scam in the past, if possible change your phone number and email address.
- Do your research. Does the employer have a LinkedIn account? Is the job posting on the official company website? If not, be cautious.

### When in doubt - Ask for help!

Contact Career Services if you are unsure about a job posting or employment offer before you send money/giftcards/ personal information to the 'employer'.

# **INTERNATIONAL STUDENTS**

# The tax-filing deadline for most individuals is April 30, 2022.

## Did you know?

- 1. International students cannot submit their first tax filing in Canada online. They must submit on paper.
- International students who are residents of Canada may be considered for the Canada Child Tax Benefit in their 19th month of residency. They must hold a valid Study Permit.
- 3. Free Tax filing help is available for low-income international students who have simple situations. Visit the CRA website or call 211 to ask about Community Volunteer Income Tax Program offices in your local area.
