

**RESIDENCE APPLICATION – PARENT/GUARDIAN CONFIRMATION FORM 2024-2025**

Concordia University of Edmonton (“Concordia”) does not accept international students under the age of 17 in its Residence Program.

**This Form AND the Custodian Confirmation Form must be completed and submitted with the Residence Application for any international student under the age of 18, or the Residence Application WILL NOT BE CONSIDERED. Applicants will be provided these forms along with their conditional acceptance and must be returned before the application will be considered complete.**

International students who will be 17 years old as of the first instructional day of their first semester at Concordia or on move-in day, whichever comes first, **must** have a Custodian who lives in Alberta. Your child may be unable to access health insurance coverage if you do not arrange for a Custodian who lives in Alberta.

Concordia cannot assist you in making arrangements for a Custodian in Alberta. You can find more information on how to make legal arrangements for a custodian on the Government of Canada website: <http://www.cic.gc.ca/english/study/study-minors.asp>.

This form must be filled out by the Student’s Parents or Legal Guardians. By completing and signing this form, you are confirming the following:

1. You have made all necessary legal arrangements to give the Custodian identified below permission to act in place of a parent.
2. The Custodian identified below lives in Alberta and has agreed to take responsibility for your child’s care, supervision and support (financial and otherwise) while your child is in Alberta, including adding your child to the Custodian’s Alberta Health Care Insurance Plan account within 3 months of your child’s arrival in Alberta.
3. You acknowledge that Concordia **cannot** act as your child’s custodian and is **not** legally responsible for the care, supervision and support (financial and otherwise) of your child.
